

MANUFACTURER'S LIMITED ONE YEAR WARRANTY

PopStops Marketing, Inc. ("Company") warrants to the original end-use purchaser that, for a period of one (1) year from the date of purchase, the **PopStops® Garage Stop** and **PopStops®** for Pets (Patent Nos. 10,748,461 and D795112 - the "Products") will be reasonably free of defects in materials and workmanship when properly handled and installed. This Limited Warranty applies to Company's products which are used and handled in the manner specified by the Company in its literature and website. This Limited Warranty applies only in the United States, U.S. Territories and Puerto Rico.

The Company will, at its option, repair or replace, if the Product fails or does not perform as warranted solely due to a manufacturing defect within the warranty period, subject to the exclusions set forth in this Limited Warranty. Repair or replacement during this one (1) year warranty shall include reasonable labor charges necessary to repair or replace the defective product, but shall not include the costs associated with shipping the product to the Company.

During the entire one (1) year warranty, Company's obligation as to repair or replacement shall further be limited to repair or replacement of the main "Garage Stop" housing unit, the end caps, mounting brackets, water bowls, the stainless steel screws, and the feet of the Products, that are available at the time of repair or replacement, and shall be limited to the repair or replacement of only the specific product that fails due to a manufacturing defect. Any repaired or replaced product shall also remain subject to the original one (1) year warranty from the date of the original purchase, and any repair or replacement shall not extend the original warranty period in any manner or start a new warranty period. This warranty is non-transferable. This warranty specifically does not cover styrene graphic inserts.

To make a warranty claim, the original purchaser must provide purchase information *(including a copy of the receipt of purchase with the date of purchase)* to the Company or the Authorized Dealer from whom the product was purchased. The owner of the product will be responsible for the cost of repair until the Company's Warranty Department has confirmed that warranty coverage exists.

Disclaimer of Warranties

The Company's Products must be stored, handled, installed, used and maintained accordance with instructions provided by Company, and this Limited Warranty is conditioned upon compliance with all such instructions. The Limited Warranty does not cover defects caused by:

- 1. Non-Compliance with Company's instructional manual. Such failures include, but are not limited to, exposure to physical abuse, including, but not limited to mishandling the Products;
- 2. Improper storage, installation, handling, use of the Product;
- 3. Damage not resulting from manufacturing defects that occur while the Product is in the customer's possession;
- 4. Unreasonable or unintended use of Product;
- 5. Products installed with a known or visible manufacturing defect at the time of installation, including, but not limited to color variances and structural integrity of the product;
- 6. Minor conditions such as paint scraping, tire marks or scratches;
- 7. Failure or dissatisfaction with appearance.
